

Criteria for Almighty's House of Restorative Services Assistance

Mission

The Almighty's House of Restorative Services is committed to improving the health of our community, helping hunger with culturally appropriate clean food. In addition, we are committed to goals that promote food justice in our community, and efficiently provide emergency food to strengthen our Nationwide community and economy.

Eligibility

Individuals or households in dire need of grocery assistance.

Residency & Citizenship

Legal Residency:

Verification of legal residency or citizenship status may be required to receive services. In addition, priority will be given to UNY citizens able to present white, blue or gold nation ID.

Acceptable forms of ID:

- United Nation of Yisrael white, blue or gold nation identification card
- Verification of the applicants residing government issued national, regional state issued driver's license
- Verification of the applicants residing government issued national, regional state issued identity card
- Verification of the applicant's school photo identification card

Disability or Special Needs

Functional Limitations:

Eligibility might be based on the extent to which a disability or special need affects an individual's ability to perform daily activities.

Employment Status:

Unemployment or Underemployment: Individuals who are unemployed or underemployed may be eligible for services.

Family Status

Single-Parent Households:



Priority of support may be available for single-parent households facing unique challenges.

Family Size:

Consideration of family size and composition when determining the level of support needed.

Health and Well-being

Health Conditions:

Certain services may require individuals to have specific health conditions or needs (e.g., mental health services, substance abuse treatment).

Emergency Situations:

Immediate Need: Provision of services in priority during emergencies or crisis situations, such as natural disasters or sudden financial hardships.

Community Engagement:

Participation in community activities, volunteering, or engagement in programs that promote social cohesion and well-being.

Claims Review Duration

Claims have a 24-72 hr processing time due to funding, and benefit awards will be subject to periodic assessments to ensure continued eligibility.

Abuse of Charity Clause and Disclaimer

Action will be taken against those who are abusing the program, if any of the following is discovered and/or revealed:

- Manipulations
- Bearing false witness of true need for food assistance,
- Suspicious behavior observed.

The repercussions of abusing the AHRS food pantry are as follows:

- Removal of any option of future assistance for individuals and if applicable all members of that household.
- Required restitution of all funds used to provide assistance
- Required zoom meeting and/or phone call with Elders to discuss the importance of not stealing from the poor and have an opportunity to repent before witnesses.



- Proverbs 22: 22-23: 22. Do not rob the poor, because he is poor, or crush the afflicted at the gate 23. for the LORD will plead their cause and rob of life those who rob them. ESV
- Leviticus 19: 11-13: 11. You shall not steal; you shall not deal falsely; you shall not lie to one another. 12. You shall not swear by my name falsely, and so profane the name of your God: I am the LORD. 13. You shall not oppress your neighbor or rob him. The wages of a hired worker shall not remain with you all night until the morning. ESV

Criteria for Priority Assistance

- Applicant is UNY citizen verifiable with identification.
- Natural disaster.
- Applicant disabled.
- Application is a Single- Parent household with one or more dependents.
- Application is experiencing Homelessness or financial emergency.
- Application is widowed or an orphan.
